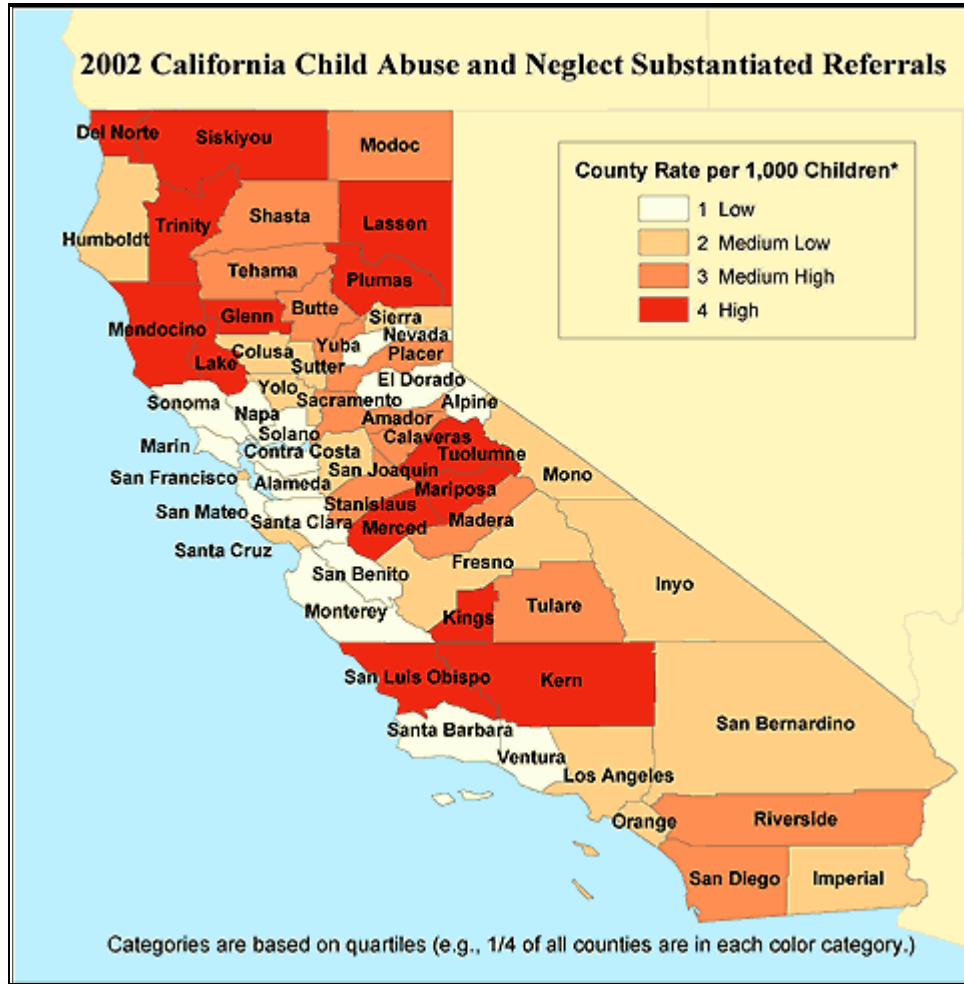


Map: Substantiation Rates
